

How people with disabilities receive support in Styria

Get information



Make an application to the local or regional authority



A team of experts will collect your individual need for support and defines a specific support plan



With this experts' advice, the authority will issue an administrative decision. This decision contains the specific type of assistance, the duration and extent of support






With the authorities' decision ("voucher") you are entitled to receive the granted support



Now find an authorized service provider which offers you the service needed (in some regions of Styria there is only one support organization – and unfortunately a lot of service providers have not enough care places and will put you on a waiting list)

If the authorities' decision does not satisfy your support need, you have the right to appeal against the decision. In this case, the authority of second instance will re-examine the facts and takes a final decision. Note that the appeal procedure will take approx. 6 months



Some specific remarks on the support system in Styria

- Styrian Disability Act ("Behindertengesetz") 2004 encloses 22 different types of support (e.g. institutional support both, full-and part-time, day care centres, training facilities, mobile assistance, personal budget and 7 special supports for people with mental illness)
- Mobile assistance should be preferred over institutional support – but in fact most of the financial resources goes directly to traditional residential homes and care centres
- About 60 service providers in Styria concentration in and around the capital of Graz. Most of them are member of the Styrian umbrella organisation "Die Steirische Behindertenhilfe".
- In Styria self-advocacy groups are badly organized and show a lack of determination and vigour

Austria has signed the

UN-Convention on the Rights of Persons with Disabilities - but ...

- ... only a few number of experts in the Federal Ministry of Social Affairs in Vienna seems to know the contents and effects
- ... Local Governments either believe that the UN-Convention does not fall within their competence – or that "everything is fine" (all specifications are fulfilled)
- In fact a lot of human rights laid down in the UN-Convention remain neglected, e.g.
 - personal assistance (Art. 19)
 - independent living (Art. 19)
 - personal mobility (Art. 20)
 - access to information (Art. 21)
 - social protection (Art. 28)



The impact of the European financial crisis ...

- 2011 the Styrian Government made a 25% budget cut including a significant reduction of the expenditures for disability services (regardless of massive public protest)
- Budget reductions also shortens the opportunities of people with disabilities: cut-down of chances, access, participation, inclusion
- Nevertheless the Styrian Secretary for Social Services is convinced, that Styria has still "one of the best service systems for people with disabilities"

Personal Budget in Styria

The purpose of the personal budget is to finance

- Personal assistance
- Household care
- Mobility support
- Support services for daily living and leisure
- Special communication facilities
- ...



Who can receive it?

- Only people with sensory or severe physical handicaps (e.g. wheelchair users, blind or partially sighted persons, hearing impaired persons ...)
- ... over 18 years old
- ... but **not** people with learning difficulties or mental handicaps

Personal Budget in Styria

... to what extent?

- Maximum of 1.600 hours per year depending on your individual support need
- ... reduced by any care allowance
- ... but **not** in combination with other support services

... how much?

- € 22,52 per hour (quarterly pre-payments; theoretical maximum of € 36.032 per year)
- ... you have to verify appropriate use of this budget



Experiences

- Until now, only 200 persons receive a "personal budget" in Styria
- Lack of information
- legal uncertainty (esp. for the administrative bodies)
- Lot of bureaucratic hurdles ("self-assessment file")



Changing rolls

- People with disabilities are no longer "costumer" or "recipient" of a service, but "employer" for personal assistants ...
- Employers must take care for income tax notification and for registration with the regional health insurance fund
- In terms of labour law, personal assistants are employees but most of them are "underground workers"
- Illegal, undeclared work put people with disabilities at high risk and may result in sanctions and penalties
